- 2. In rule 5.4(1), after sub-paragraph (c), insert the following new sub-paragraph:"(d)" for District No. 11, the persons elected in accordance with the following provisions:
  - (i) The Members in this District must elect two Executive Representatives;
  - (ii) The voting must be by a system of first past the post voting
  - (iii) The provisions of rule 5.4(1)(b) apply with respect to all elections for Executive representatives for District No. 11, but with all necessary adaptions."
