The Council is the Local Government Authority for the Cherbourg Aboriginal Shire and Trustee of the Cherbourg Deed of Grant in Trust (DOGIT). As the Local Government authority for the DOGIT the Cuncil has the responsibility of deciding what is in the best interest of the community and consider that subdividing he DOGIT into separable lots will facilitate improved land administration and create opportunities for further dealing with the DOGIT.

This includes applying to the Minister responsible for administering the Land Act 1994 for the surrender of part of the DOGIT in terms of section 56 of the Land Act 1994 for th surrender of part of the DOGIT in terms of 55 of the Land Act 1994 for the purpose of dedicating those surrendered areas as road in terms of section 94 of the Land Act 1994.
