**TRUSTEE & COUNCIL RESOLUTION**

***The Council is the Local Government Authority for the Cherbourg Aboriginal Shire and the Trustee of the Cherbourg Deed of grant in Trust (DOGIT). As the Local Government Authority and Trustee for the DOGIT the Council has the responsibility of deciding what is in the best interest of the community and we consider that approving (with conditions) the home ownership development application will facilitate improved land administration and create opportunities for private home ownership within the Cherbourg community for the benefit of all community members.***

- 1. Council as the Local Government Authority and Trustee of the DOGIT resolves to approve the development application on Lot 399 SP310061 (unregistered), lodged on behalf of Cherbourg Aboriginal Shire Council (CASC), by the Remote Indigenous Land and Infrastructure Program Office (RILIPO).***
- 2. The development application is to reconfigure Lot 399 SP2310061 (unregistered), one (1) lot into four (4) lots and a remainder lot for the purpose of creating four (4) home ownerships leases within the Cherbourg DOGIT.***
- 3. Additionally the development application is to allow the construction of four (4) dwelling houses over the relevant reconfigured lots.***
