## *Cherbourg Aboriginal Shire Council* **TRUSTEE & COUNCIL RESOLUTION**

- 2. The development application is to reconfigure Lot 399 SP280490, one (1) lot into two (2) lots for the purpose of creating a home ownerships leases within the Cherbourg DOGIT.*
