Council does not support the Cherbourg Community Safety Plan as it does not lift the Alcohol Management Plan. Council believes that the AMP is Racist, Residents incurring fines, criminal records – can't access blue cards due to the fines and Council wants it to be lifted.

Angela advised that there needs to be a broader discussion regarding AMP at a later time. In the meantime there are options such as amendments to the CSP in a staged approached to carriage limits, opening a tavern with AMP rules etc. Council and community could also take a renewed holistic approach as to why people drink and the impact.
