#### Local Laws

#### Background

On 21 July 2021, Council resolved to adopt the Proposed New Local Laws and undertake public consultation, State Interest Checks and review of the anti-competitive provisions.

#### Public Consultation

From 13 August 2021 to 10 September 2021 Council invited public consultation on the Proposed New Local Laws.

A notice inviting comments from the public was published via Council's website.

Council did not receive any substantive comments in response to the public consultation that was carried out.

Queensland South Native Title Service requested copies of the Local Laws for review on 18 August 2021 on behalf of the Wakka Wakka People, and a response was provided on the same date. No comments were received from QSNTS.

As such the road closure should not have a financial, staffing, resources impost on Councils operations or budget or impact on infrastructure services.

## Cherbourg Aboriginal Shire Council TRUSTEE & COUNCIL RESOLUTION

The Council is the Local Government Authority for the Cherbourg Aboriginal Shire and the Trustee of the Cherbourg Deed of Grant in Trust (DOGIT). As the Local Government Authority and Trustee for the DOGIT the Council has the responsibility of deciding what is in the best interest of the community. It is considered that supporting (with conditions) the permanent closure of a part of Bligh Street will facilitate the most appropriate tenure regularisation outcome given the current and continued use of the land for Police purposes, it will also improve security opportunities for the Cherbourg community and visitors which is of benefit to all community members.

- **1.** Council as the Local Government Authority and Trustee of the DOGIT resolves to support and advise the Department of Resources:
  - a. That the Cherbourg Aboriginal Shire Council does not object to the permanent closure of a part of Blight Street subject to conditions:
    - *i.* The proposed part of Bligh St to be closed, complies with DWG21\_582 Amendment 1 dated 19 May 2021, Department of Resources.
    - ii. Amalgamation of proposed closed part of Bligh St with Police Reserve Lot 43SP274901.
    - *iii.* Submission of relevant Building Application to Council for approval of access to the proposed structure on the proposed closed part of Bligh St from/to public roads.
- **2.** Council delegate authority to the Chief Executive Officer pursuant to s.257 of the Local Government Act, 2009 to progress the proceedings in Council's interests.

#### Reasons for Decision:

*The permanent closure of a portion of Bligh Street;* 

- does not interfere with the residential access that Bligh Street currently provides,
- allow for adequate access to adjacent back of properties,
- does not impact on any infrastructure and services.
