The Cherbourg Aboriginal Shire Council is Trustee of the Cherbourg DOGIT. As Trustee, Council has a fiduciary duty to address native title for matters relating to land and for tenure grants. To address native title, Council is participating in an ILUA process which will enable Council and traditional owners to perform their native title duties for various community projects, enable the grant of tenure such as leases and for administrative tenure dealings, opening and closing roads or adjusting boundaries.

The ILUA process requires Council to participate as a party to the ILUA, importantly it needs the CEO and Mayor to attend all negotiation meetings so that operational and community matters are dealt with expeditiously at meetings. To allow meetings to proceed in the absence of the CEO, the Council agrees to assign ILUA negotiation duties to a suitable Councillor who will be empowered to lead Council in future negotiation. Where the CEO is available, their attendance will be the first preference. In the absence of the Mayor, the Deputy Mayor may be assigned to participate in negotiations. Where the Mayor is available, their attendance will be the first preference.
