COUNCIL AND TRUSTEE RESOLUTION

"The Cherbourg Aboriginal Shire Council is the Trustee of the Cherbourg Aboriginal Deed of Grant in Trust and Local Government for Cherbourg. Council considers that opening the road to accommodate the Cherbourg to Murgon pedestrian path is a project of community benefit.

Council as Local Government and Trustee resolves to accept the opening of the roads as shown on plan DP331114. Council also resolves to accept any land administration actions incidental to, and necessary to facilitate lodgement and registration of the plan. We appoint the Program Office to undertake this work on behalf of Council and the community.
